- Update your software to the newest operating system.
- Make your password lengthy (at least 12 characters), this should include uppercase and lowercase characters, numbers, and symbols.
- Add multi-factor authentication to your device or any applications if they are available.
- Change your passwords at least quarterly.
- Make sure to back up all your files on a regular basis.

You may incur tax penalties under the estimated tax payment rules if your payments of the estimated tax and withholding are insufficient. Your withholding election remains in effect for any subsequent distributions unless you change or revoke the election. If you want your current withholding election to remain unchanged, no action is required. If you want to make changes to your current withholding election, please contact us or visit one of our branches to complete a new election form.
